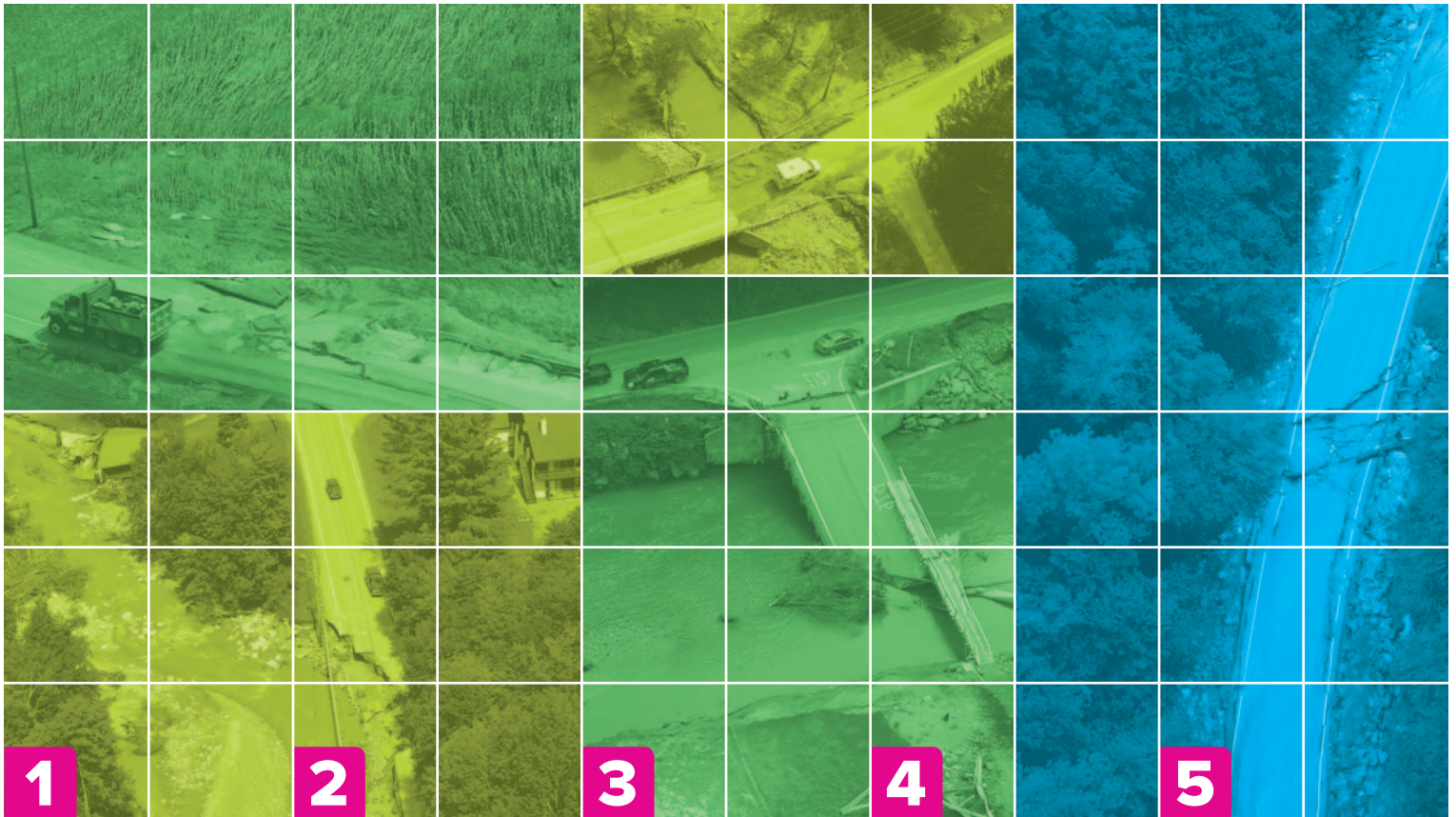

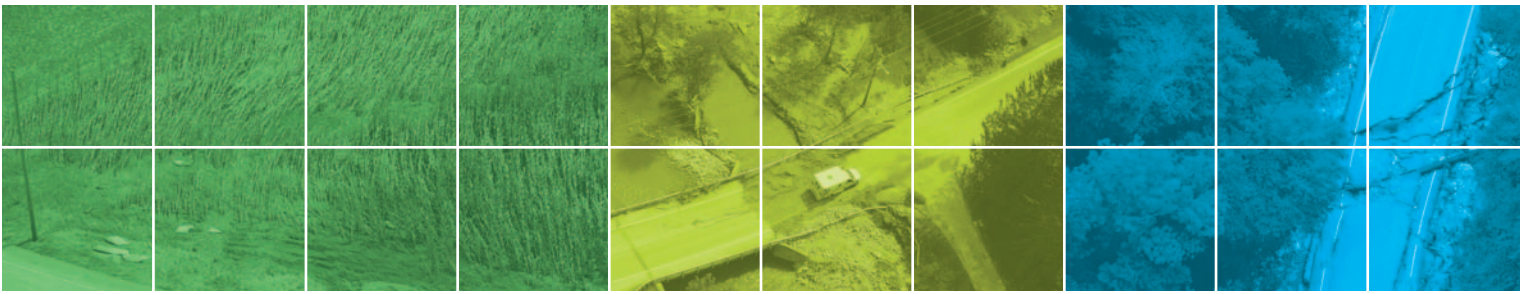
## Effective Implementation of Traffic Operations and Management

**T**he FHWA-sponsored upcoming AMPO series of Capacity Building webinars on Climate Change and Energy Planning will seek to provide a peer exchange of experiences at various MPOs, and conclude with a findings report of the diversity of challenges, ongoing and planned activities and identified needs to assist agencies in meeting these challenges within their regions.

We are continuing to seek MPO “stories” to feature in the series. - Developing traffic operations and management strategies as a response to emergency events or as an emissions reduction strategy.
